Your signature signifies that you agree to the terms contained above and within this Rental Agreement and provisions listed concerning this Rental Boat Agreement between Ideal Marine Supply and the "Renter" (Above) of a Ideal Marine Supply Rental Boat and you acknowledge and agree to pay for any such damage, theft or loss relating to your Rental with the Credit Card you have provided.

Any and all fees or cost associated with the collection of Repair/ Replacement Costs associated with any accidental damage including any and All Lawyer or Legal Fees associated with the enforcement of this (“Ideal Marine Rental Boat Agreement” will be the responsibility of the “Renter”. This is an acknowledgment to these terms signified by my signature above on page 1 of the Boat Rental Agreement Form.

Your signature above signifies that you have Inspected or have been shown the Rental Boat, Safety Gear, Anchor & Chain, Lower Unit, Skeg and the Propeller of the Rental Boat and it’s Outboard and find it to be Damage Free and in good working order. By my signature above I agree to have the Rental Boat & Outboard Engine Repaired or any parts replaced/welded if damage were to occur. I authorize the charges to be placed on my credit card that I have provided at the top of this “Boat Rental Agreement” Form... (2) Cancellation Clause: If the “Renter” gives Ideal Marine Supply (352) 498-5707 (30) THIRTY days Advanced notice we will issue a Full Refund. If you cancel “within” the 30 day period that you have Reserved a Boat, we will make every attempt to rent the boat to someone else. If we are unable to Rent the Boat to someone else, by your signature above you agree to Pay or Forfeit the One day Rental Fee/Deposit that you have sent or provided us in the form of your Credit Card.

WEATHER CLAUSE: We issue Full refunds of a Deposit if a named Tropical Storm or Hurricane is in our area. Normal and Regular Rainfall, Lightning, High winds, Fog are normal in Florida and therefore I agree by my signature above that I agree that no refund is due to such conditions. You agree not to hold us liable if we can’t provide you with a boat due to unforeseen, unexpected Damage, mechanical issues caused by a previous Renter.

Signature of the “Renter” above acknowledges this Rental Boat agreement and accepts full responsibility for the safe operation of the Rental Boat/Craft and certifying by my signature above that the Rental Boat has been shown to me/us and it is free of any damage and the craft has all the necessary safety gear for all occupants for usage of the above Rental Boat. Normal wear and tear is excluded.

(3) LAWS: Renter agrees to obey all State and Federal laws in regards and not limited to alcohol consumption, size and bag limits of all species of Marine Life. The safety of your passengers and proper navigation is the Renter’s responsibility and the “Renter” by my signature above agrees to hold Ideal Marine Supply and it’s owners harmless in any and all law suits resulting from the improper operation of the Rental Boat, alcohol related injuries, accidents with other vessels/persons and/or private property etc. Please exercise caution while renting a Rental Boat.
